CM to distribute appointment orders to newly appointed Jr lecturers

Hyderabad, Mar 11 (UNI): The Government of Telangana will distribute appointment orders to newly selected Junior Lecturers for Intermediate Colleges and faculty members for Polytechnic Colleges

in a grand event at Ravindra Bharathi Wednesday.

Chief Minister A Revanth Reddy will personally hand over the appointment orders to the selected candidates, announced Dr Yogita Rana, IAS, Secretary to the Government, Education Department.

A total of 1,292 Junior Lecturers for Intermediate Education and 240 faculty members for Polytechnic Colleges have been appointed. All selected candidates are required to report at Ravindra Bharathi by 12:30 PM to receive their appointment orders.

The Secretary to the Government, Education Department, directed the selected candidates to attend the event on time and make the most of this significant milestone in their professional journey, an official statement said.

No emergency manoeuvre or threat to IndiGo flight

Hyderabad, Mar 11 (UNI) Rajiv Gandhi International Airport (RGIA), Shamshabad, on Tuesday issued a clarification refuting recent reports claiming a major accident was narrowly averted at the airport.

In response to media coverage suggesting that an IndiGo Airlines flight from Goa to Visakhapatnam was forced to execute a reverse takeoff to avoid a potential collision, RGIA authorities confirmed that no such incident occurred.

The airport authorities emphasised that there was no threat to the flight's safety, and the reported event was misrepresented. RGIA also urged media outlets to verify facts before publishing such reports to avoid creating unnecessary concern and damaging the airport's reputation.

Minister Komatireddy Venkat Reddy meets Union Ministers to address key infrastructure projects in Telangana

New Delhi/Hyderabad, Mar 11 (UNI) : Telangana Roads, Buildings, and Cinematography Minister, Komatireddy Venkat Reddy, along with Congress MPs and officials, met Union Ministers Nitin Gadkari and Rammohan Naidu in New Delhi on Tuesday to discuss pending infrastructure projects in Telangana.

During the meeting with Union Minister Nitin Gadkari, Minister Komatireddy Venkat Reddy urged for expedited approval of several pending national highways and Regional Ring Roads in the state. He emphasised the need for Union Cabinet approval for the Regional Ring Road (RRR) project, stressing the importance of finalizing alignments, securing forest clearances, and signing the Economic



Tripartite Agreement.

Gadkari assured that preliminary work on the RRR would be completed within two months. The Minister also requested the swift sanctioning of key projects, including the construction of the Northern and

Southern parts of the RRR, the Srisailem Elevated Corridor (NH-765), five ropeway projects under the Parvat Mala scheme, 12 projects under the CRIF Setubandh scheme, and the expedited completion of the Hyderabad-Vijayawada 6-laning and Hyderabad-Manneguda 4-laning projects. Minister Komatireddy Venkat Reddy also met Union Civil Aviation Minister Rammohan Naidu to discuss aviation projects, particularly the completion

of Mamunur Airport.

He expressed gratitude for the Rs 205 crore allocated for land acquisition and highlighted that the pending Mamunur Airport project is now set to proceed, with completion expected in two and a half years. Additionally, Naidu assured the Minister that the IMD survey for Bhadradi Kothagudem Airport would be conducted soon and that feasibility studies for Airports in Jakranpally, Adilabad, Peddapalli, and Nizamabad would also be undertaken. The Minister was accompanied by MPs Ramasayam Raghuram Reddy, Mallu Ravi, Gaddam Vamsi Krishna, Chamala Kiran Kumar Reddy, Kundur Raghuveer Reddy, R&B Special Chief Secretary Vikas Raj, and Special Secretary Dasari Harichandana, according to an official statement.

Immigration bill introduced in LS

New Delhi, Mar 11 (UNI) Minister of State for Home Affairs Nityanand Rai introduced The Immigration and Foreigners Bill, 2025 in the Lok Sabha on Tuesday amid demands from the Congress and other Opposition parties that the legislation be withdrawn as it violated fundamental rights. The opposition also demanded the bill be referred to a Joint Parliamentary Committee (JPC).

Congress member Manish Tewari said the bill "is a violation of our fundamental rights on many counts".

"Either this bill should be withdrawn or should be referred to a Joint Parliamentary Committee (JPC) for very careful consideration, because it violates multiple articles of the fundamental rights under the Constitution of India," he said.

He said the provisions of the bill can be potentially misused by any government of the day if it feels that the political views or the ideological beliefs of any individual or conscientious dissenter do not conform to the views of the incumbent establishment.

TMC member Saugata Roy also criticised the bill, arguing that its provisions are too stringent for foreigners. He further pointed out the absence of Union Home Minister Amit Shah in the House.

In response, Rai stated that concerns had been raised regarding the legislative competence of the bill. However, he asserted that the bill aligns with the legislative authority and falls within the provisions of the Indian Constitution.

Rama Rao questions govt's decision to host Miss World

Hyderabad, March 11 (IANS) : Bharat Rashtira Samithi (BRS) has questioned the decision of the Telangana government to host Miss World by spending Rs.200 crore.

He asked how this could be justified when a case was booked for spending Rs.46 crore for Formula-E Race during the BRS' rule.

Rama Rao is facing a probe by Telangana Anti-Corruption Bureau (ACB) and the Enforcement Directorate for alleged irregularities in organising the Formula E-car race in February 2023 when BRS was in power.

Rama Rao took to 'X' on Tuesday to pose a question to top Congress leader Rahul Gandhi.

"Apparently spending 246 Crore for Formula-E race in Hyderabad was wrong

& will attract cases being filed. But spending 200 crores of public money to conduct Miss World, a beauty contest is right!! What is this perverse logic? Can you please explain Rahul Gandhi Ji," posted Rama Rao.

The Telangana government has decided to host 72nd Miss World in May. The decision was taken at the state Cabinet meeting last week.

The Cabinet decided to host the beauty pageant in a grand and befitting manner, ensuring top-tier hospitality and a seamless experience for all participants and guests. Spanning four weeks from May 7 to May 31, the event will be held across multiple destinations in the state.

The government said the event would reflect

Telangana's rich heritage, cultural vibrancy, and modern dynamism.

Rama Rao is facing a probe by the ACB and the ED for alleged irregularities in organising the Formula E-car race when the BRS leader was the minister for municipal administration.

The ACB on December 29, 2024 booked a case against Rama Rao, senior IAS officer Arvind Kumar and Hyderabad Metropolitan Development Authority (HMDA) former chief engineer BLN Reddy for financial irregularities.

KTR denied the allegations of any irregularities. He claimed that he worked tirelessly for bringing a prestigious event to India, to enhance the brand image of Hyderabad and Telangana globally.

According to him, the agenda was to make Hyderabad a pivotal hub for sustainable mobility.

Rescue operations in SLBC tunnel enhanced with robotic technology

Hyderabad, Mar 11 (UNI) : Special Chief Secretary for Disaster Management, Arvind Kumar, and Nagarkurnool District Collector Badawat Santosh held a review meeting with top officials on Tuesday regarding the ongoing rescue operations at the SLBC Tunnel Office.

During the meeting, officials reviewed the progress of current rescue operations and discussed future steps. They extensively deliberated on rescue procedures, the use of robotics, mechanical equipment, soil removal processes, and safety measures. Officials outlined

necessary steps to further expedite the rescue operations.

Following the state government's decision to incorporate robotic technology in the SLBC Tunnel rescue efforts, AI-based camera-equipped robots developed by Hyderabad-based Anvi Robotics were deployed on Tuesday morning. The robots, named Vijay and Akshay, were sent into the tunnel via a loco train.

Representatives from Anvi Robotics explained that they had begun setting up a communication system at the site and emphasized

that robotic technology is being employed to minimize risk and ensure no loss of life during rescue efforts.

Additionally, cadaver dogs equipped with essential tools for the operation were deployed once again to aid in the search efforts.

The meeting, among others, was attended by officials from the Geological Survey of India, Anvi Robotics, Hydra officials, the Army, NDRF, SDRF, Singareni Mines Rescue Team, RAT Miners, South Central Railway, and the Cadaver Dogs Squad from Kerala, according to an official statement.

Telangana Legislature's budget session to begin

Hyderabad, Mar 11 (UNI) The Telangana Legislature's budget session is scheduled to commence on Wednesday.

The session will open with a traditional address by Governor Jishnu Dev Varma to a joint sitting of the Legislature. Following his address, the House will be adjourned for the day. Subsequently, the Business Advisory Committee (BAC) will convene to determine the session's duration and agenda. Key legislative and policy matters are expected to be the focus of discussions.

Hyderabad, Mar 11 (UNI) The Bharat Rashtira Samithi Legislative Party (BRS) meeting, chaired by party chief K Chandrasekhar Rao (KCR), concluded after more than three hours at Telangana Bhavan here on Tuesday.

During the meeting, KCR provided directions to the party's MLAs and MLCs regarding the

KCR emphasised the importance of working collectively to address public concerns. He also informed party representatives that he would personally attend the assembly meetings, which are scheduled to commence on Wednesday.

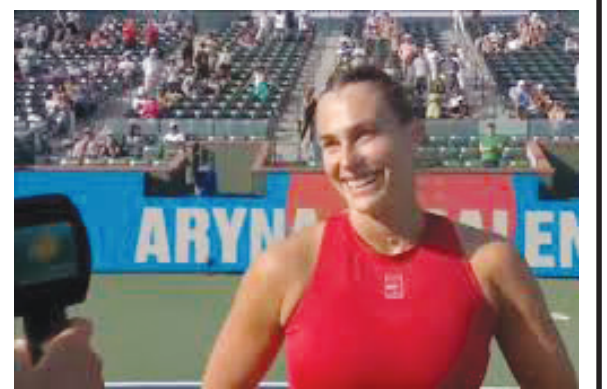

Kondaparthi village set to become model for development: Governor

Mulugu, Mar 11 : Governor Jishnu Dev Verma has called for Kondaparthi village in Mulugu district to become a role model for development across the country. The Governor announced a grant of Rs 1.5 crore for the development of the adopted village during his visit to Kondaparthi in SS Tadwai mandal on Tuesday.

During his visit, the Governor inaugurated the statues of Komaram Bheem and Birsamunda, launched digital classes in the local school, opened an Anganwadi center, a spice unit constructed at a cost of Rs. 7,84,700, and a sewing machine unit built at a cost of Rs 7,76,594. Additionally, he remotely initiated agricultural motors to support local farmers.

Addressing the gathering, the Governor noted that Kondaparthi, with 70 households and 285 residents, should serve as a model for development.

He praised the village for introducing digital classes and highlighted the



students' English-speaking skills. Stressing the importance of economic development, the Governor encouraged setting up small industries to boost self-employment among women. He expressed hope that Kondaparthi's chili, turmeric, and spice products would achieve the same recognition as Gujarat's Amul.

Governor Verma shared his vision of making Kondaparthi a model village as part of the 'Viksit

Bharat Sankalp' initiative.

He revealed that he has adopted seven tribal villages in Telangana and is actively promoting their development. The Governor commended the collaborative efforts of the state government, district administration, and tribal communities in advancing these villages.

Telangana Panchayati Raj, Women, and Child Welfare Minister Dr Danasari Anasuya Seethakka expressed her

gratitude to the Governor for his commitment to tribal welfare and for adopting Kondaparthi despite its remote forest location.

She emphasised the importance of linking the village with markets to support entrepreneurial growth among women. She highlighted recent infrastructure developments, including road construction and the sanctioning of seven borewells to boost agriculture. Principal

Secretary Dana Kishore noted that Rs 50 lakh had already been allocated for development and welfare programs in Kondaparthi. He announced plans to market the village's spice products across Telangana and mentioned that a dedicated retail space had been allotted in Hyderabad for self-help groups to promote their goods. Kishore added that modern farming techniques would be introduced across 150 acres in the region to further enhance economic growth.

District Collector Divakara TS praised the Governor's adoption of Kondaparthi, emphasising the remarkable progress achieved since then. He credited the Governor for funding Rs 70 lakh towards the renovation of the local Anganwadi center and school, transforming them with modern facilities.

The event concluded with the Governor being honored by Minister Seethakka, District Collector Divakara, TS SP Shabarish, villagers, and other dignitaries.

Police Commandant Gangaram dies in accident in residence of DSP

Sircilla (Telangana), Mar 11 (UNI) Gangaram (58), the in-charge commandant of the 17th Police Battalion in Rajanna Sircilla district, passed away following an accident on Monday night.

Gangaram had visited the residence of his friend, near the new bus stand in Sircilla. Due to poor lighting and a malfunctioning of lift, the gate opened without the lift arriving, causing Gangaram to fall from the third floor.

He sustained severe injuries and was immediately rushed to the Sircilla Government Hospital where doctors declared him brought dead.

The police battalion mourned Gangaram's death, and on Tuesday morning, officers gathered at the Sircilla hospital to pay their respects. They extended heartfelt condolences to Gangaram's family during this difficult time.

ACB catches RI accepting Rs 12,000 bribe in Medak Municipal Office

Hyderabad, Mar 11 (UNI) The Anti-Corruption Bureau (ACB) officials on Tuesday caught red-handed a Revenue Inspector (RI) from the Municipal Office in Medak Town and District while allegedly accepting a bribe of Rs 12,000. At around 1 pm, the accused officer, Nakirekanti Janaiah, was caught red-handed while demanding a bribe of Rs 20,000 and accepting Rs 12,000 from the complainant to perform an official favour.

The bribe was intended to facilitate an inquiry on the application of Ms Gelli Shailaja regarding an open plot in Sy. No. 505/1/1/2, measuring 605 square yards, belonging to her brother Srinivas. The inquiry report was to be submitted to the Municipal Commissioner of Medak Town for mutation purposes, an ACB statement revealed.

The bribe amount of Rs 12,000 was recovered from the possession of the accused officer at the Municipal Office, Medak.

Agriculture Minister participates in Rythu Nestham program

Hyderabad, Mar 11 (UNI) : Agriculture Minister Tummala Nageswara Rao, participated in the Rythu Nestham program on Tuesday. Scientists from the Rajendranagar Rice Research Station explained to farmers the management methods they should adopt to cope

with water scarcity, particularly for rice cultivation. In areas facing water shortages, scientists recommended the wet method of watering rice crops. This method not only addresses water scarcity but also provides an opportunity for higher yields. The Minister suggested that cultivating short-duration rice varieties starting in November could enable harvesting by the first week of March. He emphasised that farmers should plan their cultivation to mitigate risks posed by disasters like hailstorms. The Minister instructed Director Yasmin Basha to prioritize small and marginal farmers in the agricultural mechanization process. He directed immediate steps to provide subsidized equipment such as power tillers, power weeders, rotovators, tractor-driven equipment, and Taiwan sprayers to farmers.

Telangana Seeds Chairman Anvesh Reddy

mentioned that the company had faced losses due to improper management over the past five years. However, this year, all seeds produced by the company have been offered to farmers at reasonable prices. The company had incurred a loss of approximately Rs 90 crore in the last five years due to non-seed sales. The Minister advised the Director to ensure quality seeds for crops like pulses, lentils, sunflowers, and peanuts are provided to farmers through the Seed Development Corporation.

Stalin's Mission 2026 aggression a push for national leap

Tamil Nadu Chief Minister M.K. Stalin's sudden activism comes as no surprise, given that the state is heading toward Assembly elections in 2026, for which he has set a target of winning 200 out of the total 234 seats. To ensure a "100 per cent" victory, the ruling party needs to excel in all spheres -- be it action or rhetoric, administration or governance, perception or posturing. The government's track record and performance must be exceptional for people to vote overwhelmingly in its favour. But does Stalin's DMK government fit the bill in terms of governance, public perception, and overall satisfaction among the masses? The government has been facing challenges on multiple fronts, particularly in law and order, in addition to the anti-incumbency factor. No party achieves a sweeping victory unless there is a strong wave of sentiment -- something that, in the Indian context, is witnessed when Pakistan or China engages in hostilities or when the Indian cricket team triumphs in a major tournament. However, other factors, such as language, culture, and regional identity, if strategically leveraged, can also shift the tide in an election.

CM Stalin is well aware of this. Free welfare schemes do not always guarantee electoral success, as demonstrated in the Delhi Assembly elections, where Arvind Kejriwal's AAP suffered a massive defeat. Against this backdrop, Stalin identified his electoral weapon: the NEP's three-language formula and the issue of delimitation.

For the past few months, he has been aggressively opposing the New Education Policy (NEP) 2020, accusing the Central government of imposing Hindi through the three-language formula. Even as this debate rages on, CM Stalin has opened another front against the BJP-led Union government -- delimitation.

He argues that the population-based delimitation proposed for 2026 will be unfair to Tamil Nadu and other southern states, contending that Tamil Nadu will lose Lok Sabha seats due to its relatively slow population growth.

On March 5, he convened an all-party meet on the issue and has since written to the chief ministers of West Bengal, Andhra Pradesh, Karnataka, Kerala, Odisha, and Punjab, urging them to join forces against delimitation. He has invited them to a meeting in Chennai on March 22.

Interestingly, he has also extended invitations to BJP units in Odisha, Karnataka, Kerala, Andhra Pradesh, and West Bengal to participate in the discussion.

Stalin is forming a Joint Action Committee (JAC), stating that its purpose is "to defend our states from being silenced."

With the twin issues of language and delimitation, CM Stalin is attempting to garner support not only within Tamil Nadu but also from other opposition-ruled states. He has been posting on social media almost every morning, directly targeting the BJP, its Ministers, and its leaders.

In a post on X, he took aim at Education Minister Dharmendra Pradhan, stating: "It was the Union Education Minister who provoked us to write this series of letters when we were simply doing our job. He forgot his place and dared to threaten an entire state to accept Hindi Imposition, and now he faces the consequences of reviving a fight he can never win."

The CM also wrote, "...This is like an LKG student lecturing a PhD holder..."

His posts are provocative and appeal directly to Tamil pride: "Dravidism does not take dictations from Delhi. Instead, it sets the course for the nation to follow." ... "Tamil Nadu will not tolerate Hindi colonialism replacing British colonialism." ... "From the names of schemes to awards to Union government institutions, Hindi has been imposed to a nauseating extent, suffocating non-Hindi speakers, who are the majority in India." ... "History will remember that it was DMK that stood as the vanguard." ... "Imposition of anything breeds enmity. Enmity threatens unity."

CM Stalin and his party have been running hashtags like 'Stop Hindi Imposition' to stir public sentiment, an essential strategy for creating a favourable electoral wave. The issues of language and regional identity have historically resonated with Tamil voters.

By tapping into these emotions, Stalin is aiming to secure 200 out of 234 seats. His campaign has now reached a decisive stage -- he is no longer just addressing the local population but is working to turn this into a national issue.

He is positioning himself not just as the voice of the South but also as a key opposition leader with a strong agenda. While the North-South divide may benefit him electorally in Tamil Nadu, Stalin is also striving to elevate his stature among national leaders, aiming to be counted alongside or even above Mamata Banerjee and Rahul Gandhi.

His strategy is to turn the Dravidian identity into a national cause by linking it with regional identity, culture, and language. His ultimate goal is to construct a narrative that counters the BJP's Hindutva agenda. This will help him on several fronts -- to secure DMK's decisive victory in Tamil Nadu for the second time in a row, a feat only done by his father, late Karunanidhi, to secure the position of his son Udhayanidhi Stalin, currently a first-time MLA and Deputy CM, in the big family tree of Karunanidhi, and last to emerge as a national leader.

Females are twice likely to suffer brain bleeding than males

(Standard Post Bureau) Female mortality rate attributed to brain bleeding is higher than men. According to the reports of WHO 2020, approx 4.98 lakh fatalities occur each year worldwide out of which around 2 lakh are under the age of 50 years. A brain (cerebral) aneurysm is a bulging, weak area in the wall of an artery that supplies blood to the brain. In most cases, a brain aneurysm causes no symptoms and goes unnoticed. In rare cases, the brain aneurysm ruptures, releasing blood into the skull and causing a stroke. The most common location for brain aneurysms is in

the network of blood vessels at the base of the brain called the circle of Willis. A recent report from the Institute of Medicine (IOM), arm of the National Academy of Sciences confirms that females are up to two times more likely to develop cerebral aneurysms compared to males.

Why Are Women So Vulnerable?

There has been dearth of research in the field; it is still too early to say why women are at a higher risk than men. Since pre and post menopausal women are more likely than their younger counterparts to harbor aneurysms.

Women over the age of 35 are particularly exposed to the risk. In fact, there are several instances of sex differences in the incidence and sign of cerebrovascular disease and trauma that warrant further investigation. Smoking, high blood pressure, and a family history of brain aneurysms seem to further increase a woman's risk of developing this potentially fatal condition.

A recent data from University of Texas Southwestern Medical School in Dallas recommend early aneurysm

screening for young women smokers, alcoholic at risk, that is, those who have hypertension or a family history of brain aneurysms.

Some research also suggests that level of estrogen is also responsible for the cause. However it is still too early to derive any conclusion. Only further studies examining the relationship between estrogen and aneurysms will provide a clear answer.

Many patients (up to 30%) do not survive initial bleeding. Even the patients who survive more than 50% of patients may not survive without treatment even for a month because the aneurysm bleeds again. Haemorrhage due to aneurysms is a medical emergency that is frequently misdiagnosed. The aneurysms are diagnosed by angiography and early aneurysm treatment should be performed to prevent repeat bleeding.

Most brain aneurysms causes no symptoms and may only be discovered during tests for another, usually unrelated, condition. In other cases, an unruptured aneurysm will cause problems by pressing on areas in the

brain. When this happens, the person may suffer from severe headaches, blurred vision, changes in speech, and neck pain, depending on what areas of the brain are affected and how bad the aneurysm is.

What are the early signs?

Signs are persistent once the aneurysm ruptures and unluckily more than 50% of the cases are detectable only when it ruptures. A sudden, explosive headache - often described as the "worst headache of the patient's life" - is the cardinal symptom of a burst aneurysm. But many people walk around with silent aneurysms for years.

Other symptoms of a ruptured brain aneurysm may include:

- Headache with nausea or vomiting
 - Stiff neck
 - Muscle weakness, difficulty moving any part of the body
 - Numbness or decreased sensation in any part of the body
 - Vision changes
 - Eye lid drooping
 - Lethargy
 - Seizure
 - Speech impairment
- A number of factors can contribute to weakness in an artery wall and increase

the risk of a brain aneurysm.

Brain aneurysms are more common in adults than in children and more common in women than in men. Some of these risk factors develop over time; others are present at birth.

How can it be treated?

With the recent advancements in the field of neuro intervention, minimally invasive approach has now replaced the conventional open surgeries. Surgeries that entails direct exposure of the aneurysm and occlusion by placing a metallic clip over the affected part, involves complications like invasiveness and trauma to normal brain parenchyma. The minimally invasive approach involves treatment through endovascular means wherein a micro catheter is placed into the brain through the blood vessels in the leg.

With the use of specialized coils the aneurysm is occluded and hence the procedure is known as coiling. The procedure ensures 100% safety and has shown better outcomes. The outcomes are better with embolization for patients being treated for aneurysm.

LIC workforce shrinks nearly 14 pc in 5 years, show Govt data

New Delhi, March 11 (UNI) The number of permanent employees in public sector insurer Life Insurance Corporation of India (LIC) has declined 13.83 per cent to 98,661 over the past five years.

In a written reply in Rajya Sabha on Tuesday, Minister of State for Finance Pankaj Chaudhary said the number of permanent employees in LIC was 1,14,498 as on March 31, 2020.

As per the payroll data provided by the Minister, the number of permanent employees in LIC has shown a declining trend since March 2020.

At 98,661, the number of employees in LIC was, however, marginally up in March 2024 as compared to 98,463 in March 2023.

The reply of the Minister came in response to a question from TMC Rajya Sabha member Ritabrata Banerjee.

In his reply, Chaudhary noted that LIC is a Board governed commercial entity and the requirement of manpower is determined by the insurer keeping in view of various factors such as business requirement, spread of activities, superannuation, voluntary retirements and unfortunate demise etc.

Congress MLA Tara Bahinipati Suspended for Seven Days

Bhubaneswar, Mar 11 (UNI) Amid pandemonium in Odisha Assembly during the day, Congress MLA Tara Prasad Bahinipati was suspended from the Assembly for seven days for his unruly and indecent behavior.

Speaker Surama Padhy announced Bahinipati's suspension after a motion moved by BJP Chief

Whip Saroj Pradhan, requesting the Chair to suspend him for seven days due to his disruptive behavior, was passed by a voice vote. The Speaker directed the Assembly Marshal to evict Bahinipati from the House, barring him from attending proceedings for seven days.

BJD and Congress members demanded a voting process on the motion, but the Speaker rejected their request, prompting BJD members to stage a noisy walkout from the House. While moving the motion, BJP Chief Whip Saroj Pradhan stated that Congress MLA Tara Prasad Bahinipati had insulted the Speaker by throwing posters at her on Monday.

On Tuesday, Bahinipati also climbed onto the Speaker's podium and attempted to snatch the

microphone but was stopped by security staff.

The BJD strongly condemned the Speaker's ruling to suspend the Congress MLA and urged her to reconsider the decision. BJD MLA Arun Sahu stated that senior party MLAs would meet the Speaker on Wednesday to request a withdrawal of her ruling, calling it unilateral and undemocratic. Meanwhile, Congress MLAs decided to stage a sit-in protest near the Gandhi statue inside the Assembly premises, wearing black badges to oppose the Speaker's decision. Congress MLA Tara Prasad Bahinipati stated that party MLAs would continue their protest throughout the night and would not stop until his suspension order was revoked. Bahinipati alleged that the Speaker made a unilateral decision and did not allow the Opposition's demand for a division on the motion brought by the BJP to suspend him for seven days. He also claimed that Congress had submitted the names of BJP members who allegedly assaulted him and other Opposition members during the

commotion inside the House on Tuesday, demanding strict action against them.

The Odisha Assembly has been witnessing continuous disruptions for three consecutive sessions since March 7, as Opposition BJD and Congress members have been stalling proceedings over various demands.

While the BJD has been demanding a clarification from Chief Minister Mohan Charan Majhi on BJP MLA Jayanarayan Mishra's divisive statement, Congress members have been protesting against the rising atrocities against women in the state.

The situation escalated on Tuesday when the Speaker attempted to continue House proceedings during the question hour despite protests from Opposition members inside the well of the House. The agitated Opposition members climbed onto the Speaker's podium, stood on the reporter's table, raised slogans while holding posters, and attempted to obstruct Urban Development Minister Krushna Chandra Mohapatra during the

Question Hour.

This led to a pandemonium in the House, as Treasury bench members rushed into the well in defense of the Minister, resulting in a scuffle between Treasury bench members and Opposition BJD and Congress members. Sensing the situation was spiraling out of control, the Speaker adjourned the House at 10:43 AM until 12:10 PM. Subsequently, the House was adjourned eight more times throughout the day until 5:40 PM due to continued Opposition protests. The Speaker appealed to Opposition members to return to their seats and cooperate in the functioning of the House, but they did not heed her appeal and continued their protest. The House was adjourned nine times without transacting any business, except for 13 minutes during the Question Hour and a brief period from 12:30 PM to 1:28 PM, during which 17 BJP members condemned the Opposition's unruly behavior and demanded strict action against them for disrupting House proceedings for the past three days.

J&K Police arrest 4 drug peddlers with contraband cash

Srinagar, Mar 11 (UNI) : Police have arrested four drug peddlers and recovered contraband and cash from their possession in Kashmir valley, an officer said on Tuesday.

In a drive against the menace of drug trafficking in Awantipora, a police team of Police Station Pampore at a checkpoint established at Kadlbal Pampore, intercepted a vehicle with three persons on board.

During the search, officers were able to recover 290 grams of Charas like substance and cash Rs 97,500 (proceeds of narcotic crime) from their possession.

The accused have been identified as Nazir Ahmad Wani of Sumurbugh New Colony, Mukhtar Ahmad Mir of of Dooru Mirmaidan Anantnag and Javid Ahmad Kawa a resident of Sumurbugh New Colony were arrested and the

vehicle used in the commission of crime has also been seized. Accordingly, a case vide FIR Number 29/ 2025 under relevant sections of NDPS stands registered at Police Station Pampore.

Another drug peddler was arrested during checking at Khazan Mati, Kralpora in Kupwara district. The accused, identified as Muneer Ahmad Lone, a resident of Kralpora, was intercepted when he was moving in a suspicious manner. During his search, a cannabis-like substance (apparently charas) was recovered from his possession.

He has been arrested and a case under relevant sections of law has been registered at Police Station Kralpora and investigation has been initiated.

'Need to overhaul outdated systems to promote inclusion of disabled individuals'

New Delhi, Mar 11 (UNI) : Lok Sabha MP Shashi Tharoor on Tuesday called for urgent actions to promote inclusion of disabled individuals into society, stressing the need to overhaul the outdated systems.

He emphasised that the legislative framework should not look like relics of a bygone era.

Pointing to gaps in policies, and calling for urgent steps to ensure proper utilisation of allocated budgets, Tharoor stressed that it is essential to reconceptualize disability inclusion not merely as a social imperative but as an economic and political necessity, a statement said.

Moreover, he also gave a clarion call to "change conventional paradigms and work collaboratively toward a future where the principles of equality, dignity, and inclusion are not mere aspirations but lived realities."

Tharoor, while delivering the keynote address at 'Empowering Inclusion: A Dialogue on Disability, Politics and Economic Inclusion' organised by National Centre for Promotion of Employment for Disabled People (NCPEDP), said, "While our legal edifice recognizes disability as a critical dimension of human identity, the implementation of these rights has not kept pace with the nation's aspirations. In our contemporary socio-political milieu, persons with disabilities are still underrepresented in governance, sidelined in policy deliberations, and overlooked in budgetary allocations."

Meanwhile, Fouzia Khan, Rajya Sabha MP, while highlighting the urgent needs for streamline data on disability, said, "In 2025 census we should have a separate segment for disabled people. In the absence of accurate data the resource allocation and effective policy intervention becomes a big hurdle."

Former Maharashtra MLA and founder of Prahar Janshakti Party Bachchu Kadu, highlighted the need to streamline budgetary allocations and ensure their judicious use to reach the benefits to the disabled people.

"Ensuring the rights and dignity of persons with disabilities requires more than just philanthropy - it demands concrete policy action, substantial budget allocation, and stringent implementation. While Maharashtra has taken big steps towards inclusion, the challenges remain vast. From inadequate funding to inaccessible education and technology, we must move beyond token measures and commit to systemic change. Only then can we build a truly inclusive and empowered society for all," he said.

Lok Sabha MP Pratap Sarangi called for creating a more humane and equitable society and asking for empathy for the disabled to be able to realize their true potential and mainstream them into our social and economic fabric.

Members of the disability advocacy groups urged the Parliamentarians that there is merit in considering the need to move beyond token representation and ensure robust legal and policy frameworks for disability inclusion.

Witness fails to identify vital documents in Sheena Bora case

Mumbai Mar 11 (UNI): City-based advocate Gregory D'Souza, who notarised the Will of Peter Mukerjea and Indrani Mukerjea related to a flat in New Delhi, could not identify the documents in the court in the sensational Sheena Bora murder case trial which has resumed after a four-month break, a lawyer said here on Tuesday.

The trial in the murder case will now be held daily and Indrani, the deceased's mother, is a key accused. As per the said Will, Peter had transferred his half-share to Indrani, who had bequeathed the entire flat in the name of Sheena in September 2004.

The prosecution examined D'Souza, a notary advocate, as its 97th witness. As per the prosecution's case, Peter and Indrani owned a three bedroom-kitchen flat in New Delhi. On September 15, 2004, Peter bequeathed half of his share to Indrani. The same day, Indrani bequeathed her own share

and the share given to her by Peter to Sheena, mentioning her daughter as her "sister".

The prosecution had examined 96 witnesses till November 2024, after which the special judge hearing the case was transferred, bringing the trial to a standstill. In February, a new judge was assigned, after which the case came up for hearing last Friday.

Indrani Mukerjea, the alleged biological mother of Sheena, is the prime accused in the case, along with co-accused Sanjeev Khanna and driver Shyamwar Rai strangled Sheena in a car on April 24, 2012. It is alleged that the body was later dumped into a bag and kept overnight in the garage before being set on fire in Raigad's Pen village the next day.

Govt to submit proposal for reducing consumers' power bill: CM, Fadnavis

Mumbai, Mar 11 (UNI): The government will bring an independent solar energy-based scheme for electricity consumers, Chief Minister Devendra Fadnavis said on Tuesday, averring that it has submitted a petition before the state regulatory commission proposing consistent reduction in the power bill for the next five years.

Fadnavis said the

Central government has introduced the 'Pradhan Mantri Suryaghar Free Power Scheme' for consumers consuming 0 to 300 units of electricity. Through this scheme, 'root top solar' panels are being provided to such customers, he said during Question Hour in the Assembly.

The state government will bring an independent

scheme to support this scheme of the central government, he said.

The Chief Minister said his government was trying to reduce the electricity rates in the state, and towards that end, it has submitted a multi-year tariff petition for the next five years to the Maharashtra Electricity Regulatory Commission.

The petition provides

that electricity rates will decrease every year in the next five years in the state.

Among the Electricity Regulatory Commissions in the country, Maharashtra is the first state to submit a petition to the State Electricity Regulatory Commission for reducing electricity rates every year for the next five years, added Fadnavis.

HC asks lower court to take right decision on cancellation of bail of self-styled journalist Prashant Kortakar

Kolhapur, Mar 11 (UNI) The Bombay High Court on Tuesday directed a court in Kolhapur to take a right decision on cancellation of interim bail given to self-styled journalist Prashant Kortakar, who had allegedly threatened historian Indrajeet Sawant over his comments in a TV debate on Hindi film 'Chhaava' based on the life of Chhatrapati Sambhaji Maharaj. Notably,

Kortakar had called history researcher Indrajeet Sawant twice and had threatened him for allegedly spreading hatred against the Brahmin community while participating in a debate on Hindi film 'Chhaava' and had also made an objectionable statement against Chhatrapati Shivaji Maharaj and his son Chhatrapati Sambhaji Maharaj. After a complainant was lodged against him,

the Juna Rajwada police in the city tried to arrest Kortakar, who managed to secure an interim bail from the Kolhapur district court. Upon this, police filed an appeal in the HC seeking to cancel his bail for custodial inquiry.

In today's hearing, the Bombay High Court refused to interfere in the case and directed the local court of Kolhapur to take appropriate decision after hearing the side of the state government in this case.

Complaint of financial embezzlement against former trustees of Lilavati Hospital

Mumbai, Mar 11 (UNI): The Lilavati Kritilal Mehta Medical Trust, which oversees city's famous Lilavati Hospital, has initiated legal action against former trustees for alleged large scale financial embezzlement.

While addressing a press conference here on Tuesday, former Mumbai police commissioner Parmbir Singh, presently executive director of the Lilavati Hospital Trust, said that the Trust has formally lodged a complaint with Enforcement Directorate

(ED) and Bandra Police Station against its former trustees and other related individuals. The complaint alleged massive financial misappropriation of Rs 1,300 crore and a total of three FIRs (first information reports) have been lodged by the current Permanent Trustee Prashant Mehta against erstwhile trustees and their related companies, he said.

The Trust also alleged black magic being performed and theft in their premises.

Singh alleged that

former trustees performed black magic against the present board of trustees on the hospital premises.

Eight 'kalash' (urns) filled with bones and human hair were found buried under the floor in office where the current trustees sit every day in Lilavati Hospital. The trustees approached the Bandra police station and filed a complaint.

Then, the hospital management approached Bandra court, and the court itself initiated an inquiry into the black magic matter.

Govt eases norms for selection of 125 Deputy District Officers in Revenue Dept

Mumbai, Mar 11 (UNI) ; In order to speed up people-oriented works of the Revenue administration in Maharashtra, the government has taken a decision to give selection category to 125 Deputy District Collectors in the state and 80 of these officers have been cleared to become

Additional Collectors. An official press statement issued on Tuesday stated that after working for 10 years as Deputy Collector, they will be regularised in service as Deputy Collector (Selection Grade), thereby increasing their pay structure.

As a result, some of these senior Sub-District Officers will get the opportunity to

become Additional Collectors.

There was a backlog of non-promotion in the Revenue service for many years, however, due to this decision, the revenue works will now be speeded up. In the next period, preparations have been started for the promotion of Tehsildar to Sub-Collector as well as for filling up the post of Deputy Collector through the State Public Service Commission (MPSC), the statement added.

Accordingly, a seniority list was finalised, 125 Sub-Collectors have been selected and the stalled District Caste Verification Committee chairman posts have also been filled, it stated.

Govt honours 'Sofosh' Pune with 'Balsnehi Award'

Pune, Mar 11 (UNI): 'Sofosh' Pune, which has been actively involved in the protection, rehabilitation, and adoption process of orphaned and destitute children for more than 60 years, was recently honoured with the prestigious 'Balsnehi Award 2024' by the Maharashtra government. The award has been given in the category of 'Best Specialised Adoption Agency.'

The award was presented during a programme organised by the State Commission for Protection of Child Rights at the Yashwantrao Chavan Centre here. Minister of Women and Child Development Aditi Tatkare, state minister Meghna Bordikar and Commission chief Sushiben Shah were present during the program.

Himachal Assembly passes Rs 17,053.78 cr supplementary budget for 2024-25

Shimla, Mar 11 (UNI) The Himachal Pradesh Assembly on Tuesday passed a supplementary budget of Rs 17,053.78 crore for the financial year 2024-25. Chief Minister Sukhvinder Singh Sukhu, who holds the portfolio of finance, presented the first and final installment of the supplementary budget, which was approved without discussion. The House also passed the Himachal Pradesh Appropriation Bill, granting the government authority to utilise these funds.

Out of the total amount, Rs 15,776.19 crore is allocated for state schemes, while Rs 1,277.59 crore is designated for centrally sponsored schemes. The key allocations under state schemes include Rs 10,137.07 crore for wage and means advances and overdraft payments, Rs 1,033.63 crore for power

generation and infrastructure repair, and Rs 814.94 crore as subsidies for fare concessions and electric bus purchases for Himachal Road Transport Corporation. Additionally, Rs 763.26 crore has been allocated for pensions and retirement benefits, 7455.91 crore for medical colleges and healthcare schemes, and 7329.44 crore for water supply and sanitation projects. Furthermore, Rs 303.67 crore is earmarked for disaster relief, Rs 173.25 crore for tourism development, Rs 150.19 crore for school infrastructure repair, and Rs 142.83 crore for grants to rural local bodies. Other allocations include Rs 135.88 crore for road and bridge construction, Rs 130.16 crore for women's hostels and welfare schemes, Rs 127.77 crore for government buildings, and Rs 124.50 crore for railway projects.

Punta Cana/New Delhi, Mar 11 (UNI): An Indian-American student named Sudiksha Konanki has gone missing since March 6 in Punta Cana, a resort town in the Dominican Republic.

The Dominican authorities have intensified their search for the young woman, who had gone to Punta Cana for a holiday and was spending time at the beach with five friends.

The young woman was staying at the Riu República hotel in the Arena Gorda area. The Riu Hotels & Resorts hotel chain said in a statement that it is collaborating with the authorities to find Sudiksha's whereabouts.

The father of Sudiksha Konanki, a 20-year-old American student, has urged authorities to expand their investigation and consider the possibility of kidnapping. Subbarayudu Konanki questioned the initial focus on the water, suggesting that if his

Moving forward, only those dressed in traditional Indian clothing will be permitted entry into the temple premises. This decision was taken by the Board of Trustees of Shri Martand Devasthan, Jejuri, with the aim of maintaining the sanctity of the temple.

Both male and female

devotees must adhere to the prescribed dress code, which prohibits inappropriate or revealing clothing. Items such as torn jeans, Bermuda shorts, skirts, and other fashion apparel deemed unsuitable for a sacred space will not be allowed.

Jejuri's Khandoba is a Kuladaivata of many farming families, Brahmins, and the nomadic Dhangar tribe of the Maharashtra and Deccan region.

According to legends and folklore, Khandoba was a human avatar of Bhagawan Shiva; he used to live and rule the region from Jejuri-gad (transl. Jejuri fort), where the Mandir is now present.

The Mandir is also known as Jejuri-gad. Khandoba killed the demon brothers Mani and Malla when they harassed people.

March 6, she and Ribe, along with four others, went to the beach. By 5:05 a.m., only Konanki and Ribe remained.

After more than three hours without surveillance footage, Ribe was seen leaving alone at 8:52 a.m. Konanki was officially reported missing at 4:00 p.m.

Her disappearance has launched an extensive search operation utilizing advanced technology, including planes and drones. Riu Hotels also indicated that support is being provided to the authorities in the search and an emergency protocol has been activated to ensure that all necessary measures are taken. In addition, they have enabled an internal communication channel so that the employees of the five hotels in the Punta Cana destination who have relevant information can share it with the hotel or the authorities, the news paper reported.

Centre revokes suspension of Wrestling Federation of India

New Delhi, Mar 11 (UNI) : The Ministry of Youth Affairs and Sports on Monday revoked the suspension of the Wrestling Federation of India (WFI), restoring its recognition as the National Sports Federation (NSF) with immediate effect. The decision ensures Indian wrestlers' participation in upcoming international events, including the 2026 Asian Games and the 2028 Olympics.

The WFI had been suspended on December 24, 2023, due to governance lapses, including violations of the National Sports Development Code of India, 2011, and a lack of transparency in operations. In response, an Ad-hoc Committee appointed by

the Indian Olympic Association (IOA) had taken over the federation's responsibilities.

The suspension was lifted following a ministry review of WFI's corrective actions, findings from a spot verification committee, and legal observations from the Delhi High Court. Additionally, United World Wrestling (UWW), the global governing body for the sport, had reinstated WFI's membership on February 13, 2024, with conditions such as the re-election of an Athletes' Commission and the assurance of fair selection processes. As part of the reinstatement, the ministry issued key directives to WFI to ensure good governance and transparency. The

federation must revert amendments made during the suspension period within four weeks to restore a balanced power structure.

Moreover, non-elected individuals, including former office bearers and terminated officials, must remain completely dissociated from WFI and its affiliated units. All selections for international events must be conducted in a fair and transparent manner, adhering to the Sports Code and UWW regulations. The government reaffirmed its commitment to upholding good governance, ensuring compliance with the Sports Code, and prioritising athlete welfare to foster a robust sporting ecosystem in the country.

Meanwhile, Australian Open champion Madison Keys from the United States claimed a 6-2, 6-7 (8), 6-4 victory over Elise Mertens of Belgium while world No. 3 Coco Gauff of the United States defeated Greece's Maria Sakkari 7-6 (1), 6-2.

Rajiv Kumar Jatiwal, who won his only title on his professional debut back in 1998, made all his gains early in his round as he collected five birdies between the first and the 10th and followed that up with an eagle on the 11th.

The 48-year-old's eagle came as a result of a 10-foot conversion. All aspects of his game came together as Rajiv sank two more long birdie putts and landed his wedge shots within four feet on two other occasions for birdies. He narrowly missed a hole-in-one on the eighth where he also landed a birdie.

Rajiv said, "I'm really pleased with this effort considering the course conditions were quite tough as the wind was up when I was playing. I couldn't have asked for a better start. It's important for me to just keep it going from here on. I've had a decent start to the 2025 season on the main tour and that has given me the confidence coming into this week."

Historic 150th Anniversary Test match to be played between Australia & England in 2027

Melbourne, Mar 11 (UNI) To celebrate 150 years of the first-ever Test match between fierce rivals, a day and night Test will be played between Australia and England at the iconic MCG in the year 2027.

The 150th anniversary celebration Test match in 2027 will have a distinctly modern feel, with Cricket Australia today confirming it will be the Australian men's first under lights at the Melbourne Cricket Ground.

The match, commemorating the first ever Test, played between Australia and England in Melbourne in 1877, will be the first men's day-night Test at the venue, and follows the successful women's Ashes day-night Test at the MCG this summer, according to a Cricket Australia media release. The announcement comes to mark two years out from the match, which has been confirmed to be played March 11-15, 2027.

That will make it the latest in the home summer a men's Test has been staged in Australia since the 1978-79 series against Pakistan (which ended on March 29). CA holds contractual rights to use



the MCG until the end of March each summer, despite the venue often being used for Australian Rules football in that month. CA recently extended its venue hire agreement with the MCG until the 2030-31 summer.

While the MCG's annual Boxing Day Test is hugely popular, the move to a day-night Test for the 150th Anniversary match, which will start on a Wednesday, is designed to encourage attendance outside of the school holiday period.

A day-night Test should also prove attractive for the UK television audience. Regular Ashes

Tests hosted on Australia's east coast typically begin just before midnight in England, but a later start means early-rising UK fans will be able to watch the final two sessions.

The match, which will come after Australia's five-Test Border-Gavaskar Trophy series in India that year, is likely to mean the late arrival of Australia and England players to the 2027 IPL, with IPL franchises told to expect that year's tournament to run between March 14 and May 30.

The 1977 Centenary Test – held from March 12-17 – was a lavish occasion to which every living men's cricketer who had

represented either Australia or England in an Ashes match was invited.

Her Majesty Queen Elizabeth II met the competing teams on-field during the tea break on day five, shortly before Greg Chappell's Australia completed a 45-run win over Tony Greig's men, remarkably mirroring the result of the inaugural match a century earlier.

In that first match, played from March 15-19, including a rest day on the Sunday, Charles Bannerman hit 165 before retiring hurt, setting a record that still stands with 69.6 per cent of Australia's first-innings total of 245.

Team India Women's Kabaddi Team felicitated, receives Rs 67.50 lakh reward

New Delhi, Mar 11 (UNI) : The Indian Women's Kabaddi team was felicitated on Tuesday following their triumphant title defence at the 6th Asian Women's Kabaddi Championship in Tehran, with Union Minister for Youth Affairs and Sports Dr Mansukh Mandaviya announcing a cash reward of Rs 67.50 lakh for the team.

Recognising their achievement, Mandaviya also revealed plans to launch a women's kabaddi league to provide more opportunities for female athletes, mirroring the men's league. "We will take all efforts to support our female athletes. Prime Minister Narendra Modi wants our girls to get equal opportunities in the development of Viksit Bharat," he stated at the felicitation ceremony.

Dr Mandaviya further disclosed that, during the recent Chintan Shivir in Hyderabad, a decision was taken to encourage

corporate sponsorship in sports. "The government will do everything necessary to develop indigenous sports, including kabaddi. We will encourage the corporate sector to adopt sports and provide financial backing for training and infrastructure development," he said.

The Indian Women's Kabaddi team successfully defended their title by overcoming hosts Iran 32-25 in the final held on Saturday. The tournament, returning after an eight-year hiatus, was previously held in Iran in 2017, where India triumphed over South Korea to lift the trophy.

With this latest triumph, India continues its dominance in the sport, having also secured gold at the 2023 Asian Games in Hangzhou, China. This victory marks India's fifth title win at the Asian Women's Kabaddi Championship, reinforcing its stature as the undisputed powerhouse of

the sport. Placed in Group A alongside Thailand, Bangladesh, and Malaysia, India advanced comfortably to the final, securing dominant victories over Bangladesh (64-23), Thailand (76-21), and Malaysia (73-19), finishing with an impressive cumulative score difference of +150. In the semifinal, India defeated Nepal 56-18, setting up a title clash with hosts Iran. Despite facing stiff competition, Team India prevailed 32-25 in the final. Captain and raider Sonali Shingate attributed their success to rigorous training at SAI Sonapat, which played a crucial role in their preparation. She also expressed gratitude for the Supreme Court's intervention, which ensured the Indian team's participation in the championship. "We are grateful to the Supreme Court for enabling our participation. This victory belongs to every member of our team, who played

magnificently to ensure we returned as champions," Shingate said.

As the team's captain and a formidable raider, Shingate played a crucial role in India's victory. Her leadership on and off the mat ensured that the team remained focused throughout the tournament. "Now, we look forward to the Women's Kabaddi World Cup in Bihar this June," she added.

Amateur Kabaddi Federation of India (AKFI) Secretary-elect Jitendra Pran Singh Thakur lauded the team's achievement, calling it a significant milestone ahead of the Women's Kabaddi World Cup. "This victory reinforces India's dominance in kabaddi and highlights the growing strength of our women athletes on the international stage. The AKFI remains committed to supporting their participation in upcoming tournaments," he stated.

TT icon Sharath Kamal announces retirement

Chennai, Mar 11 (UNI) : Indian table tennis icon Aachanta Sharath Kamal on Tuesday announced his retirement from professional play, marking the end of a remarkable 22-year international career.

The 42-year-old athlete will make his final appearance at the WTT Star Contender Chennai 2025, scheduled from March 25 to 30 at the Nehru Indoor Stadium in Chennai.

Reflecting on his journey, Kamal remarked, "Having represented India for nearly 22 years and dedicated almost 38 years to the sport, I feel I have contributed to the best of my ability as a player. Now, it's time to give back as an administrator, mentor, and coach."

He added that concluding his career in Chennai is fitting, as his international journey began there in 1999 during the Junior Asian Championships.

Kamal's career is marked by an array of achievements, solidifying his status as one of India's greatest table tennis players.

He won 13 medals across five Commonwealth Games, including seven golds, with a standout performance in 2006 when he clinched gold in both men's singles and team events. His historic

contribution to Indian table tennis includes leading the national team to a bronze medal at the 2018 Asian Games, the country's first in the sport at the event in 60 years. On the domestic front, Kamal dominated as a ten-time national champion, while also making an impact internationally by reaching a career-high world ranking of 30 in 2019. His consistency and ability to challenge top players on the global stage have been instrumental in raising India's stature in table tennis.

His contributions to the sport have been recognized with several prestigious awards, including the Arjuna Award in 2004, the Padma Shri in 2019, and the Khel Ratna Award in 2022.

Beyond his on-table achievements, Kamal has played a crucial role in promoting table tennis in India. He serves as the Co-Chair for the ITTF Athlete's Commission alongside Chinese legend Liu Shiwen and is an ambassador for the ITTF Foundation, focusing on grassroots development of the sport.

As he transitions from player to mentor and administrator, Sharath Kamal's legacy will continue to inspire future generations of Indian table tennis players.

Capacity increase of the transformer at Mahatransco's Anandnagar substation

Appeal to consumers in Ulhasnagar, Ambernath and Badlapur to use electricity wisely



(Standard Post Bureau) Kalyan, March 11 : The work of increasing the capacity of one of the three 50 MVA transformers at Mahatransco's 220/22 KV Anandnagar substation to 100 MVA has been undertaken since Tuesday (11 March) morning. This work is expected to be completed by the midnight of 20 March. The capacity increase work has been started as unanimously decided in a joint meeting of various industrial associations and consumers, Mahatransco and Mahavitaran.

Power supply to industrial consumers on 13 express feeders in Anandnagar MIDC has been planned in a circular manner through the remaining two 50 MVA capacity transformers at Mahatransco's Anandnagar substation. It is also planned to continue

uninterrupted power supply to other consumers supplied from this substation. Meanwhile, until the work is completed, all electricity consumers under Ulhasnagar Sub-Division 4 and 5, Ambernath East and West, Badlapur East and West are appealed to use electricity wisely by Mahatransco and Mahavitaran. Mahatransco's Anandnagar Sub-Station supplies electricity to consumers in Ulhasnagar, Ambernath, Badlapur areas including Mahavitaran's Anandnagar Industrial Estate.

The entire load of Mahavitaran's Kharwai and Poddar Sub-Stations, which are supplied with electricity from Anandnagar Sub-Station, has currently been diverted to Mahatransco's 100/22 kV Morivali Sub-Station. Badlapur East is supplied with electricity from Kharwai

and Poddar Sub-Station. Badlapur West is supplied with electricity from Mahavitaran's Sonivali Sub-Station. Currently, the load of some parts of Badlapur West has been diverted to Mahatransco's 220/22 kV Jambhul Sub-Station.

The above planning has been made jointly by Mahatransco and Mahavitaran to ensure that the power supply of the consumers in the concerned areas is not disrupted until the capacity expansion work is completed. This too may lead to power supply disruption due to increased load or unavoidable technical reasons.

Therefore, Mahavitaran has appealed to use electricity as little as possible during this period and to cooperate in this work. The capacity expansion work will enable better service to be provided to all the electricity consumers in the area.

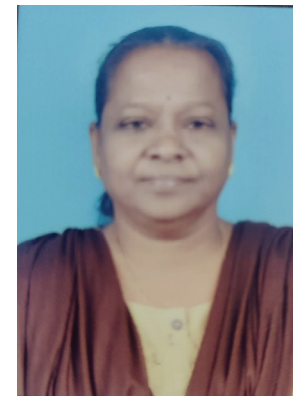

Steps afoot to mitigate floods, says Meghalaya CM

Shillong, Mar 11 (UNI) Meghalaya Chief Minister Conrad Sangma on Tuesday said that steps were afoot to mitigate the impact of floods caused by heavy rainfall in the plain areas in the State.

Replying to queries during the Question Hour in the assembly, Sangma said that the government was working on a weather forecasting system integrated with new technologies to better predict major flash floods or

cloudbursts. "Multiple steps are being taken. Wherever interventions are possible, whether through the water resources department, the soil and water conservation department or the forest department, various measures have been implemented in different areas. Of course, these are not completely foolproof, as weather conditions today are quite unpredictable," he said.

"More importantly, we are developing a weather

forecasting mechanism that incorporates new technologies, satellite imagery, and other advanced tools. This allows us to predict major flash floods or cloudbursts in advance, though not with absolute certainty. With advancing technologies, we are now able to issue weather warnings in most situations," the Chief Minister further informed.

Sangma also informed that the Disaster Response

Fund stood at Rs 322 crore, while the Disaster Mitigation Fund was Rs 81 crore over the past five years. "Last year alone, the government spent Rs 71 crore out of the Rs 322 crore DRF to assist disaster-affected areas. We have amended the rules to allow Deputy Commissioners to provide housing materials, if necessary, for affected households. Additional funds have also been placed at their disposal.
