

Hoshiarpur, March 4 (UNI) Taking a tough stance against the agitating Tehsildars, Punjab Chief Minister Bhagwant Singh Mann on Tuesday said that the state government will not bow before "corrupt" officers, who are facing Police action for their "sins". The Chief Minister, who undertook a whirlwind tour to get the work of registration started at Kharar, Banur and Zirakpur tehsils, said the revenue officers had gone on mass leave in the wake of vigilance action against their corrupt officers.

He said the AAP government has zero tolerance against corruption but ironically by going on mass leave these officers are seeking license for corruption. Mann said such blackmailing will not be tolerated and severe action will be taken against the corrupt and haughty officers.He said their pressure tactics will not be tolerated at any cost and exemplary action will be taken against

them. The CM said the state government will recruit new Tehsildars and Revenue officers in the coming days, the agenda for which will be brought in the Cabinet.

He said the officers harass the common man on a daily basis but this will no longer be tolerated and the government will take strict action against them.

Mann said the officers who are going on mass leave should remember that after they return to work from their leave, when and where they will join will be decided by the people. He said the state government is ready with plan 'B' for tackling such "tantrums" and if needed powers of Tehsildars will be delegated to teachers and professors for smooth registration process.

He said the state government is committed to safeguarding the interests of the common man by all means and no one will be allowed to take them for granted.

(UNI) Chief Minister Yogi Adityanath on Tuesday highlighted the remarkable transformation in Uttar Pradesh's law and order situation and said there was a time when the mafia held sway, chasing people while the police retreated and even saluted them.

Participating in the budget debate in the state assembly, the CM said, "However, the state's image has significantly changed, earning respect from people across the country and the world. UP, once avoided by investors, has now emerged as the nation's top investment destination."

Citing NCRB data, he detailed the substantial decline in crime rates between 2016 and 2024. "There has been a reduction of 77.43 percent in the case of loot, robbery cases dropped by 84.41 percent, murder cases by 41.01 percent, violence and arson 66.40 percent, by housebreaking by 5.12 percent and kidnappings for ransom by 54.72 percent," he said.

Yogi emphasised that the legacy of past governments, which allowed lawlessness to thrive, been has dismantled. "The 'One District, One Mafia' era is now a thing of the past, replaced by a secure and stable environment built through eight years of consistent efforts," he said. He attributed this success to comprehensive police reforms, which included enhancing improving facilities,

training, adopting technology, ensuring transparency, fostering public communication and modemising policing practices.

SAD demands immediate SC quashes rape case against Ex-Army Officer

release of farmer leaders arrested in pre-dawn swoop

Chandigarh, March 4 (UNI) : Senior Shiromani Akali Dal (SAD) leader Bikram Singh Majithia on Tuesday demanded the immediate release of farmer leaders who had been arrested at the instance of Puniab Chief Minister Bhagwant Mann.

The SAD also asked the Chief Minister to apologise to the leaders for threatening and misbehaving with them during an official meeting yesterday.

Expressing shock at the manner in which leaders of the Samyukt Kisan Morcha (SKM), who had been invited for talks by the Chief Minister yesterday, were being treated, Majithia said "Mr Bhagwant Mann threatened the Kisan leaders with dire consequences when he was reminded of the promises he had made to farmers before assuming charge as chief minister in 2022".

He said this was followed up with raids and arrests of Kisan leaders in a pre-dawn swoop today in a bid to foil the March 5 agitation announced by them.

Reminding Mann about the promises made by him to farmers, the Akali leader said "Mann assured farmers

and farm labourers that the Aam Aadmi Party (AAP) would remodel farm policies to ensure no farm suicide occurred in the State. He also assured farmers that farm income would be doubled and that his government would

> implement the Swaminathan Report whether the centre did that or not. Farmers were also assured that every crop would be procured by the State on Minimum Support Price (MSP)".

Asserting that the Chief minister had reneged on each and every promise made to the farmers, Majithia said "when he was reminded of these promises he started threatening the farmers and walked out of the meeting rather than face them". Asserting that it was the democratic right of farmers to ask questions from the Chief Minister they had elected to power,

he said "such an erratic and unstable behavior is unbecoming of a chief minister".He also requested AAP Convener Arvind Kejriwal, now on a visit to Punjab to attend a

Vipasana session, that Mann needed this treatment more than him and should be asked to attend the same to stabilize himself.

New Delhi, Mar 4 (UNI) : The Supreme Court on Tuesday quashed all criminal proceedings in a rape case against former Indian Army officer Rakesh Walia, ruling that the complaint was "unbelievable" and constituted an "abuse of the process of law."

A bench comprising Justice Sudhanshu Dhulia and Justice K. Vinod Chandran noted that apart from the complainant's statements, no evidence was on record to substantiate the allegations.

Additionally, it was found that the same complainant had filed eight other identical First Information Reports (FIRs) against different individuals across multiple police stations in Delhi, but later refused to cooperate with investigations. The Bench emphasised that this was a case where the Delhi High Court should have exercised its powers under Section 482 of the Code of Criminal Procedure (now Section 528 of the Bharatiya Nagarik Suraksha Sanhita) to quash the proceedings.

Since the High Court had dismissed Walia's plea for quashing the case, the Supreme Court set aside the order and terminated all proceedings. The apex court noted that "Apart from her statement in the FIR and her statement under Section 164 of the Code of Criminal Procedure, 1973 (now under Section 183 of the Bharatiya Nagarik Suraksha Sanhita, 2023), there is no other evidence on record. However, what is most concerning before this Court is that the same respondent has filed nearly identical cases against at least eight other individuals (nine cases in total).

These FIRs, lodged in different police stations across Delhi, involve offenses under Sections 34, 328, 354, 354A, 354D, 376, 377, 506, and 509 of the IPC. Additionally, we have been informed that after lodging the FIR, the complainant has not cooperated with the investigation and has not appeared before this Court despite being served with notice," the Supreme Court observed.

The complainant had alleged that when she met the appellant regarding a modeling assignment, he offered her a cold drink laced with sedatives, after which he raped her. However, the appellant refuted these claims, stating that their meeting was related to services she offered for promoting his books. He asserted that he was an author of five books, some of which were bestsellers.

"Considering the nature of the case and the cumulative circumstances, we are of the opinion that the criminal case initiated against the appellant is nothing but an abuse of the process of law. This is precisely the kind of case where the High Court ought to have exercised its inherent powers under Section 482 Cr.P.C. (now under Section 528 B.N.S.S.) and should have quashed the proceedings," the bench ruled.

New Delhi, Mar 4 (UNI) The Supreme Court on Tuesday ruled that addressing a person as "Miyan-Tiyan" or "Pakistani" in poor taste does not constitute an offence under Section 298 of the Indian Penal Code (IPC) related to hurting religious sentiments.

Discharging an individual from the charge under Section 298 IPC (uttering words with deliberate intent to wound religious feelings), the Court stated, "The appellant is accused of hurting the religious feelings of the informant by calling him 'Miyan-Tiyan' and 'Pakistani.' Undoubtedly, the statements made are in poor taste. However, they do not amount to hurting the religious sentiments of the informant."A bench

comprising Justice B.V. Nagarathna and Justice Satish Chandra Sharma was hearing an appeal against a judgment of the Jharkhand High Court, which had refused to discharge the appellant from the case.

The FIR was lodged by an Urdu translator and acting clerk (Right to Information) at the Sub-Divisional Office, Chas.

The complainant alleged that when he visited the appellant to provide information related to an RTI application, the accused verbally abused him made references to his religion, and used criminal force to obstruct his official duties.Consequently, charges were framed against the appellant under Sections 353, 298, and 504 of the IPC.The Supreme Court, however, found that

the complaint did not establish the necessary ingredients for these offences. It observed that there was no evidence of assault or use of force by the appellant to warrant a charge under Section 353 IPC.Additionally, the Court held that the appellant could not be charged under Section 504 IPC, as there was no act on his part that could have provoked a breach of peace.Senior Advocate A. Sirajudeen, along with Advocates Arya Kumari, Divya Singhvi, Pardeep Gupta, Parinav Gupta, Mansi Gupta, and Vipin Gupta appeared for the Accused.

Leopard sighting on Alipiri walkway in Tirupati sends panic among devotees

Tirupati, March 4 (IANS) : A leopard was sighted on the Alipiri walkway in Andhra Pradesh's Tirupati early on Tuesday, triggering panic among local shopkeepers and devotees.

The leopard was sighted on the walkway near Galigupuram with its movements captured on CCTV footage in a shop around 1 a.m. The shopkeeper alerted

the officials of the Tirumala Tirupati Devasthanam (TTD). The TTD officials advised devotees to use

the walkway only in groups. As a precautionary measure, they also restricted access for children under the age of

12.Two weeks ago, a leopard was sighted near Muggu Bavi on the walkway. It had retreated into the woods. However, the TTD security personnel had been providing security to devotees.

After the latest incident, the TTD officials, along with the Forest Department, have put in place additional security measures.

Alipiri walkway is used by hundreds of devotees every day to reach the Sri Venkateshwara temple atop Tirumala hills. The 9-kmlong route has 3,550 steps to reach the hill shrine.

In January, a leopard was sighted near Alipiri on the foothill of Tirumala hills,

sending panic among the residents of Tirupati as well as the pilgrims.

A contract employee of TTD's Aswini Hospital was injured when he encountered a leopard while travelling on a bike on

Alipiri-Cherlopalli road. The big cat jumped off the road median to cross the road towards the abutting forest. Muni Kumar fell from the bike when he panicked upon seeing the leopard.

Leopards have been making frequent appearances on this road during the last several months.

A six-year-old girl was mauled to death by a leopard on August 11, 2023. She was walking to

"When the matter was listed on January 31, 2025, we directed it to be listed on February 10, 2025.

Senior Advocates Mukul Rohatgi and Shekhar Naphde appeared for respondent No. 3. Though not recorded in writing, we recall having asked Mr. Rohatgi whether the Speaker would specify a timeline for deciding the matter to avoid court intervention. Consequently, we listed it

for February 20. On that date, Mr. Rohatgi informed us that he had instructions from the Secretary that no such statement could be made on behalf of the Speaker."Justice Gavai

the decision affects [them]."The observations came after BRS and its MLAs pointed out that the disqualification petitions against defected MLAs have been pending for over six months with no progress. The petitioners highlighted that one of the defected MLAs even contested the Lok Sabha election on a Congress ticket, while another was actively campaigning for the Congress party, and others were seen with the Telangana Chief Minister wearing Congress flags.

The petitioners that the contended Speaker's failure to act on the disqualification petitions amounted to a failure of "constitutional mandate.'

"Today, when the matter is called, an objection is raised by Dr. A.M. Singhvi and Mr. Rohatgi, stating that no formal notice was issued, preventing the respondents

regarding principles of natural justice. Therefore, we issue a formal notice to the respondents."

During the hearing, Senior Advocate Aryama Sundaram, representing the petitioners, disputed the respondents' request for additional time to file a response, alleging it was a delaying tactic. He argued that the respondents had earlier stated their intention not to file a counteraffidavit, and nearly a year had passed without any progress in the case.

Justice Gavai referenced the Supreme Court's ruling in Subhash Desai v. Principal Secretary, Government of Maharashtra, which held that the Speaker must decide disqualification petitions within a "reasonable period" but did not specify a timeframe. Sundaram, however, contended that the present case raised distinct issues not directly covered by

their replies before the next hearing and scheduled the matter as the first item for hearing on March 25.

While some respondents waived formal notice, the Court instructed the Registrar General of the Telangana High Court to ensure service of notice to the remaining respondents. The Court also clarified that any pleadings from the respondents must be filed before the returnable date.

In a lighter exchange, Senior Advocate Dr. A.M. Singhvi quipped that he was well-suited to argue such cases as he had previously been a "victim"—a reference to his representation of petitioners seeking disqualification of Uddhav Sena MLAs who defected to Shinde Sena. Justice humorously Gavai responded that the Court could discharge Singhvi from representing the respondents and instead appoint him as an Amicus.

21 Indian startups raise over \$105 million in funding this week

About 21 Indian startups collectively raised approximately \$105.87 million this week, with securing funding across different stages.

Among them, three startups raised funds at the growth stage, while 16 early-stage startups attracted investments.

In the previous week, nearly 22 startups raised around \$184.4 million. On average, in the last eight weeks, startup funding has stood at approximately \$317.35 million per week, with around 28 deals taking place weekly.

In the growth-stage funding, B2B cross-border e-commerce startup Geniemode led the chart by raising \$50 million in a Series C round backed by Multiples Alternate Asset Management.

MOC Cancer Care & amp; Research Centre secured \$18 million in a Series B round led by Elevation Capital, while a fintech unicorn raised \$12 million in debt from AK Capital Finance.

'BJP's double engine' govts are proving to be curse for daughters: alleges Congress

New Delhi, Mar 4 (UNI) The Congress on Tuesday alleged that under the 'BJP's double-engine governments', incidents of crimes against women have surged, while concrete action remains lacking.

Addressing a press conference here, All India Mahila Congress President Alka Lamba said that Prime Minister Narendra Modi's promises of protecting daughters are proving to be mere rhetoric, raising questions about the government's commitment to women's security.

"BJP's 'double engine' governments in the country are proving to be a curse for daughters. Haryana, Madhya Pradesh, Maharashtra, Gujarat, Uttarakhand, Rajasthan, wherever you look, many heinous crimes have been committed against daughters and the police is remaining a mute spectator in these cases," she alleged.

A case of molestation of the daughter of a Union Minister and her friends has come to light in Maharashtra. After the FIR, it was revealed that the molester was a former BJP councilor, Lamba said.She said he has been seen in photographs with the Chief Minister of Maharashtra and other senior BJP leaders. If the Union Minister himself is denied justice, he may have to step down from his position and join the fight for his daughter's cause, along with many others facing similar struggles. The All India Mahila Congress President said that on March 8, the International Women's Day will be celebrated, but what about the crimes being committed against daughters?

"In Pune, a 19-year-old girl was gang-raped at knifepoint, and a video of the incident was recorded, yet no action was taken. Meanwhile, Gujarat has witnessed 17,000 cases of crimes against women over the past nine years, with nearly 200 girls approaching the police every month in search of justice, she alleged.

In Gujarat, a BJP MLA was booked for the rape of a Dalit woman following the High Court's directive. This incident highlights how the police appear to side with the perpetrators rather than supporting the victims, Alka Lamba said.She further claimed that crimes against women are rampant in BJP-ruled states and that many of these incidents have connections to BJP members.

The next time your dog looks at you, panting and with his tongue out, he's not asking for a pat on the head, he might be suffering a sunstroke. That's one of the key symptoms of the heat-based illness, say experts. "We get an increasing number of complaints about pets suffering from sunstroke," says

veterinarian Dr Persis Ghiara. "Pugs and boxers are more affected as they are more hyper. The more excitable a dog is, the more he is running around, pulling things, the more susceptible he is to the heat," she adds. Another huge reason for this is when pet owners go shopping and leave their pets in a car without the window rolled down,

Dogs need to have cold treats in summer as they get heated up really fast. These have to be allnatural and are just meant to cool them down. Says dog food maker Yadika Sharma, "Dogs can't have sugar, but you can sometimes give them an ice cube to play around with, just make o a t sure the cube is of a size that they

Spa-cial remedies Dogs need skin care in summer just like humans do. Says animal

care professional Gauri Keskar, "Dogs get rashes, hotspots etc and what helps the most is if

you trim 50% of their hair. This makes them cooler and more comfortable. The other important thing is to give them anti-tick and flea baths. You also have soothing aroma baths

-like cucumber-watermelon, mild olive and strawberry-apple. And to soothe the skin, there are

- Hose him with cool shower or let him stand in a tub of water.

Put a cold compress on his head to lower the body temperature.

- Rush him to the vet who will administer an intravenous to hydrate him as well as (sometimes) an anti-histamine, so the animal does not go into shock.

Some quick solutions Dr Ghiara presents a few easy tips to help pets to battle the hot season...

1. If you have an air-conditioner at home,

From jumping into the pool, to getting some spa 'TLC' and licking on doggie icecreams, animals are finding their own way to beat the heat

If you keep the dog in the verandah, make sure there is an enclosure or covered porch space.

4. Let your dog take a dip in the pool if you have one. But pet pools are expensive and rare, so instead have a portable spool at home for it. You could give the dog a hand shower once a day, if say, the dog has been out for a long while. But my advice is that it is preferable to take it out for a walk before 7 or 8 am and after 6 in the evening.

Heat stroke in cats Cats cannot tolerate rising heat. Their breathing starts to becme shallow and it can escalate into heatstroke. Cats pant or sweat through their foot pads so as to get rid of this excess heat. It is important to help a cat cool down or else the temperature can result in organ damage or even death.

Watch out for these signs: - Restlessness and panting

- Sweaty paw pads
- Higher rectal temperature

- Redness of the tongue and mouth

- Vomiting What to do immediately:

Says Dr Dipti Valavalkar, "It's important to keep cats out of the direct sunlight as much as possible. But in case the cat does suffer from heatstroke, keep it in an airconditioned or cooler environment. Put a wet cloth on it. You must also rush the animal to the vet who will see what is wrong, monitor the cat and administer the right medications to it."

Heard of paw booties?

As the hot tar road and pavement can hurt the dog's paws, you can get your pet dog booties. "These are good but they only protect the paws and cannot prevent heatstroke. Also, dogs may not be acceptable to wearing them," warms Dr Ghiara.

Patel. "I have had two to three cases like this already. Now, temperatures are touching 40 degrees and to leave dogs or even animals like cows, tied up outside in that heat, is hazardous for them." With the mercury set to rise even further, make sure you know how to help your pet cooled down the right way. There's a lot one can do, from exotic treatments at the spa, to simple techniques and even foods that can help them battle the

(Contd from page 1) the Supreme Court's ruling in Subhash Desai v. Principal Secretary, Government of Maharashtra, which held that the Speaker must decide disqualification petitions within a "reasonable period" but did not specify a timeframe. Sundaram, however, contended that the present case raised distinct issues not directly covered by Subhash Desai.

To ensure procedural clarity, the bench directed the respondents to submit their replies before the next hearing and scheduled the matter as the first item for hearing on March 25.

While some respondents waived formal notice, the Court instructed the Registrar General of the Telangana High Court to ensure service of notice to the remaining respondents. The Court also clarified that any pleadings from the respondents must be filed before the returnable date.

In a lighter exchange, Senior Advocate Dr. A.M. Singhvi quipped that he was well-suited to argue such cases as he had previously been а "victim"—a reference to his representation of petitioners seeking disqualification of Uddhav Sena MLAs who defected to Shinde Sena. Justice Gavai humorously responded that the Court could discharge Singhvi from representing the respondents and instead appoint him as an Amicus.

The Supreme Court is currently hearing two petitions one filed by BRS and its MLAs challenging the Telangana Legislative Assembly Speaker's delay in deciding disqualification petitions against seven MLAs who contested the

2023 Assembly election on a BRS ticket but later joined the Congress. The defected MLAs include Srinivas Reddy Parigi, Bandla Krishna Mohan Reddy, Kale Yadaiah, T. Prakash

Goud, A. Gandhi, Gudem Mahipal Reddy, and M. Sanjay Kumar.

Another petition filed by Telangana MLA Padi Kaushik Reddy regarding the defection of three MLAs—Venkata Rao Tellam, Kadiyam Srihari, and Danam Nagenderfrom BRS to Congress.

The functioning of the conveyor belt plays a crucial role in expediting the movement of excavated debris, construction supplies, or other necessary materials within the tunnel, thereby it will be easier to trace missing workers, officials said.

The conveyor belt system is utilised to facilitate the smooth and efficient transportation of materials, ensuring uninterrupted progress in the tunnel's construction or maintenance work.

The fate of eight persons, hailing from Jharkhand, Uttar Pradesh, Punjab and Jammu & Kashmir, is still unknown as multiple teams, comprising 2 agencies of the Centre and the state government, continued the rescue operation

dewatering process is progressing swiftly.
